## GENERAL INFORMATION

**ENTRY LIMITS:** Handler/Dog Teams may enter one, two or all three components each day. (elite must enter all components)  
A handler may enter only one dog in any given component per level per day. Your dog must have passed the prior level for a component to register for the next level, unless entered as FEO and available space allows this, after regular entries are full. No onsite registrations will be accepted. Open to all breeds & mixes.

**Please advise 24 hours prior to trial if bringing a bitch in season.**

**FEES:** \$35.00 per component entered (advance and excellent)  
\$100.00 for elite entry
